Abstract: Opposition parties in Indonesia today, especially during President Jokowi's first government period (2014-2019) and second period (2019-2024), many have failed to carry out their function as political watchdogs and cooperate well with the government, which has resulted in instability in the landscape. state politics. This research aims to understand the impact of party opposition on the stability of Indonesian democracy. The research methodology used in this research is a systematic literature review using 192 scientific articles sourced from the Scopus database. Articles reviewed using the Vosviewer application. Based on the findings of this research, opposition parties have a significant impact on the development of democracy in the Indonesian political system because they provide good stability for the reform of the country's political system. Opposition parties in parliament have different methods from the agreed government. Opposition parties can work together in various ways, for example by criticizing government policies.

For example (Alper & Lancaster, 2023) explain that "one of the most essential factors of modern democracies is the role played by parliamentary oppositions." Conversely, regarding the relationship between the opposition and the governing class, Salvatore Valitutti states that "the democracy breathes by two lungs, by the lung of the opposition and the lung of the majority." As stated in Jaja (2022), Mladenović (2022), states that "in a democratic country, a political party is the most visible manifestation and unquestionably one of the most effective forms of opposition." This indicates that opposition is a necessary condition for a democracy to function effectively in a given nation. Furthermore, political parties with closer ties to the government or the people themselves tend to have stronger resolve. Due to this, political opposition parties can effectively convey their disapproval and hatred towards them.

The study concluded that there were no opposing opinions in the 1945 Constitution. However, this statement would not be helpful if the opposition party's members were to remain neutral and lack both strength and courage (Jackman & Maitrot, 2022). This is due to the fact that there are subtle protests taking place against the government and civil society, which are components of the opposition itself. According to Jha (2023), given the political party's considerable strength and commitment to advancing public policy, it is quite likely that their efforts will contribute to the achievement of the general public's goals. Apart from that, there are some people who believe that the opposition party does not adhere to Pancasila democracy, which upholds Islamic law. As a result, they are unknown in the national political sphere (Gherghina & Bankov, 2023). If most of the population opposes something, it might hinder the opposition's process of forming a group since opposition can only be formed if the majority of the population opposes it. Not with standing this, it is important to understand that the political parties in the aforementioned legislative body are composed of the opposition and coalitions, which serve as both the governing and legislative branches' representatives in matters of policy that are made by the government, whether at the national or local level. It is not true to say that most people do not always expect the opposition party to support their aspirations when the government enacts laws that have the advantage of not hurting the general populace.

Even so, a lot of research has shown that opposition parties in Indonesian politics are not only related to the functions of watchdog, critic, and mediator; they also play a role in upholding accountability, examining, and evaluating every government action, and pressing

the government to clarify policies or laws that are enacted as a result of opposition parties participation in public debates and responsiveness to the needs of the general public. Opposition is a phenomenon that occurs in various fields. In general, opposition is described as "being in opposition to something" or "having a position that differs from that of something else (Hjermitslev, 2023)."Since the 1998 political reform, the majority of Indonesians, particularly those who support democracy, have made democracy their preferred course of action.

The focus of this research is to answer the question, "How can opposition parties in Indonesia initiate and carry out their functions effectively within the government system?" To address this question, the study used a qualitative content analysis method with SLR testing and Vosviewer article analysis. This study contributes to the advancement of knowledge, particularly the knowledge of government that is related to opposing parties in Indonesia, as well as to the policies and functions of government.

Opposition parties operate as a control mechanism against the stagnant government. The opposition can ensure that the government does not violate democratic principles and citizen rights by undermining government activities and decisions (Kazlauskaitė & Salmela, 2022). Opposition is not simply an anti-government or disparate group; it is an existence that provides criticism and alternative policy proposals as well as control over how the government operates. As a result of the implementation of power controls, the opposition is "rational partiality" (Hohendorf et al., 2020). As Dahl believed more than forty years ago, a healthy opposition is both a component and a representation of a strong democracy. Practical aspects of the Indonesian opposition and democracy will be discussed in the next discussion (Sitandang & Firdaus, 2024). Critical analysis and constructive evaluation from the opposition parties help to strengthen the government's credibility and curb the use of force. In a democratic system, opposition parties create more inclusive politics and more expansive popular representation.

Even though they are not in the government, opposition parties nevertheless have the right to voice their desires and concerns about groups that may not be well-served by their more powerful counterparts. Thus, the opposition parties assert that the government's decisions undermine the people's rights (Hinfelaar et al., 2022).

The opposing party serves as a monitoring mechanism for the government that is currently in disarray. The opposition was perceived during the Old Order as a counter-revolution and as something that was either not natural or was being "planted" by foreign forces (Mietzner & Honna 2023). In the meantime, the opposition during the Order era was labeled as belonging to radical circles or being contra development or contra Pancasila. They uphold the laws and decrees of the government and criticize any dissension or lack of understanding regarding the fundamental principles of democracy and the interests of the people (Gharti, 2022). The presence of opposition parties makes the government more accountable and open to criticism and advice from many organizations. This policy helps to curb the spread of prostitution and government corruption. Opposing parties strive to

strengthen political discourse (Irwin, 2023), of a democratic system, political dialogue is crucial to achieving consensus and accurately expressing differences of opinion.

Opposition parties engage in active debate and discussion in the political arena. Critiques and counterarguments to the policies put out by the opposition parties encourage healthy debate and deepen public understanding of important issues (Hatab, 2023). This discussion helps the public become more vigilant and ensures that the laws that are passed will not impede the development of various viewpoint. In the Indonesian context, for example, (PDIP) has occasionally been used as a counterargument to the Pemilu reforms of 2004 and 2009. Even though the PDIP currently holds the first rank in the quick count results of the Legislative 2024, this party states that it is obligated to remain outside the government and the DPR as the opposition in order to carry out the function of check and balance (Firdiansyah et al., 2024).

In the current research study on (Yu., Wojcieszak, & Casas, 2023) explain opposition parties' tactics in democracy, some important issues that are related to the stability and progress of the democratic system are highlighted. Below are a few eye-catching examples. Initially, the opposition party's stance on the advancement of democracy Research indicates that opposition parties have a significant negative impact on the stability of the democratic system in the Indonesian government (Lee., Ha, & Lee, 2023). The implementation of policy should be based on the needs and goals of the state (Kaul, 2023; Kefale, 2023). includes the general public and the private sector. This principle emphasizes the importance of cooperation and synergy between the government, private sector, and the general public in order to achieve the goal of "Together" (Burlock, 2022). 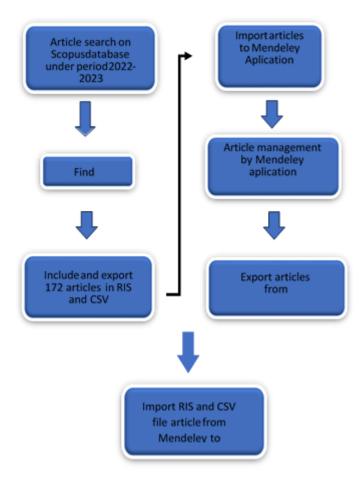


Figure 1. Scheme research methods

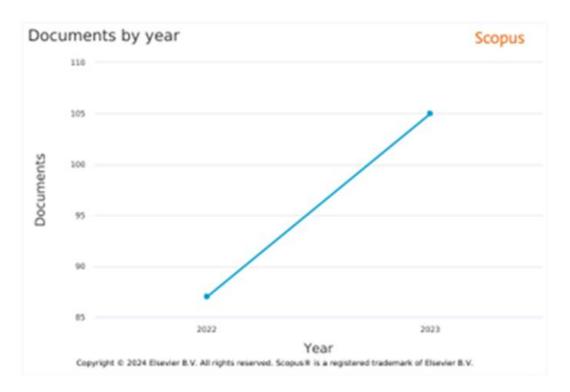


Figure 2. Research based on a year's worth of data regarding the concept of opposing parties in various countries

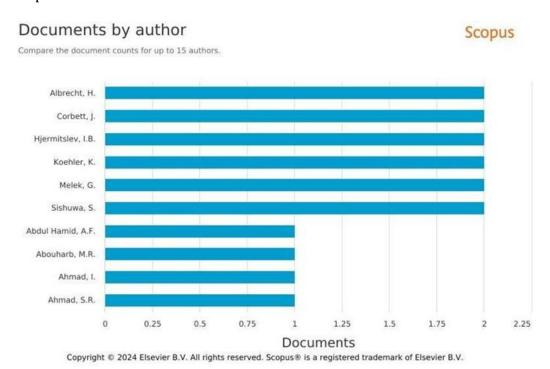


Figure 3. Research on the role of opposition parties based on a few countries from the scope.

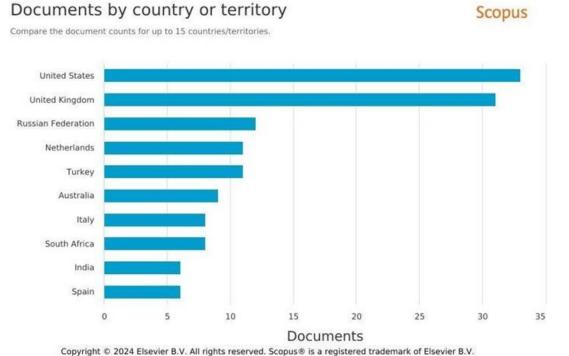
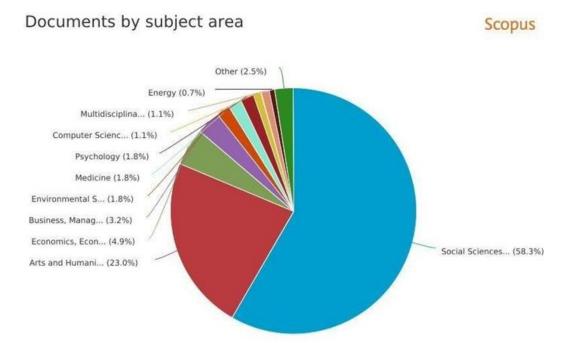


Figure 4. Trend research based on several countries from Scopus about the role of opposition parties

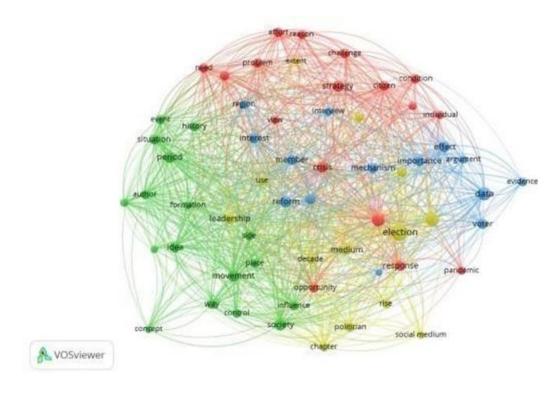


Figure 6. Visualization of the development map of the role opposition parties research.

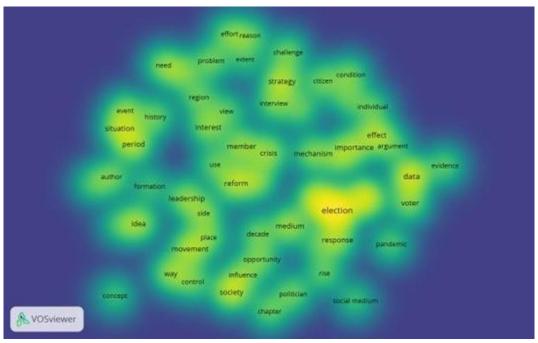


Figure 7. Civil density visualization community and state cooperation
